**2010 LEGISLATORS OF THE YEAR
ASSEMBLYMAN PEDRO NAVA
SENATOR DEAN FLOREZ**

AB 979 by Assemblyman Tom Berryhill re: Hunting. Oppose. Vetoed

Would have prohibited cities/counties from passing local ordinances on hunting/fishing.

AB 1437 by Assemblyman Jared Huffman re: Eggs . Support. Passed.

Requires eggs from out of state to meet housing requirements under Prop 2, which requires room for chickens to spread their wings.

AB 1656 by Assemblywoman Fiona Ma re: Fur. Support. Vetoed.

Would have required labeling on fur as to species and country of origin.

AB 2012 by Assemblyman Ted Lieu re: Cruelty. Support. Vetoed.

Would have strengthened and clarified that animal abusers can be charged with misdemeanors or felonies.

AB 2223 by Assemblyman Pedro Nava re: Hunting. Support. Failed.

Would have prohibited hunting with lead shot in state wildlife areas.

AB 2411 by Assemblyman Dave Jones re: Pet Insurance. Support. Vetoed.

Would have required pet insurance companies to provide better consumer info, such as defining pre-existing conditions.

AB 2743 by Assemblyman Pedro Nava re: De-Clawing. Support. Vetoed.

Would have prohibited landlords from requiring de-clawing of cats or de-barking of dogs as a condition of residency.

SB 250 by Senator Dean Florez re: Pet Overpopulation. Support. Failed.

Would have required spay/neuter of dogs/cats with numerous exceptions.
