## 2013 LEGISLATOR OF THE YEAR ASSEMBLYMEMBER ANTHONY RENDON

**AB 339 by Assemblymember Dickinson re: Flea Markets. Support.  
PASSED. Prohibits the sale of animals at flea markets unless there is a  
local ordinance with minimum standards.**

**AB 711 by Assemblymember Anthony Rendon re: Lead Ammunition. Support. PASSED. Prohibits the use of lead ammunition for hunting. Lead shot poisons wildlife.**

**AB 754 by Assemblymember Al Muratsuchi re: Coastal Protection. Support. PASSED. Provides state tax check off “Protect Our Coast and Oceans Fund.”**

**AB 976 by Assemblymember Toni Atkins re: Coastal Commission. Support. FAILED. Would have given authority to the Coastal Commission to levy fines against violators.**

**AB 1213 by Assemblymember Richard Bloom re: Bobcats. Support. PASSED. Requires Cal Fish & Wildlife to have a management plan by July 2015. If not, trapping of bobcats will be prohibited. Bans bobcat trapping around Joshua Tree National Park.**

**AB 1323 by Assemblymember Holly Mitchell re: Fracking. Support. FAILED. Would have declared a moratorium on “fracking” (cracking underground rocks to get oil) until regulations are passed by the Division of Oil, Gas, and Geothermal Resources. Fracking affects wildlife, the environment, and can contribute to earthquakes.**

**SB 405 by Senator Alex Padilla re: plastic bags. Support. FAILED. Would have prohibited grocery stores from providing single use plastic bags. Plastic bags kill wildlife and are a major source of pollution.**
