## **LEGISLATORS OF THE YEAR**

**Senator Ricardo Lara, D-33**

**Assemblymember Richard Bloom, D-50**

**SB 1062 by Senator Ricardo Lara re: Elephants. Support. Passed.** Bans the use of bull hooks, baseball bats and other devices used to inflict pain and instill fear in elephants.

**AB 2755 by Assemblymember James Gallagher re: Beehives. Support. Passed.** Provides for damages in a civil action for the wrongful and willful taking, possessing, harboring, or transporting a beehive, removal of bees from a hive, or killing bees.

**SB 945 by Senator Bill Monning re: Pet Boarding Facilities. Support. Passed.** Establishes standards and procedures for the care and maintenance of pets boarded at a pet boarding facility: The construction, sanitation, hours pet may be left unobserved, number of pets in an enclosure, availability of food and water.

**AB 2505 by Assemblymember Bill Quirk re: Euthanasia. Support. Passed.** Prohibits the use of carbon dioxide gas to kill a cat or dog.

**AB 1825 by Assemblymembers Richard Gordon and Brian Maienschein re: Vicious Dogs. Support. Passed.** Redefines a ‘vicious dog’ to a dog that inflicts severe injury on, or kills a human being when unprovoked.

**AB 797 by Assemblymembers Marc Steinorth and Miguel Santiago re: Pets in Hot Cars. Support. Passed.** Prohibits any civil liability or cause of action against a person who is rescuing or providing care to an animal in a locked car.

**AB 2269 by Assemblymember Marie Waldron re: Pets for Experimentation or Testing. Support. Passed.** Prohibits an animal shelter that accepts animals from the public or takes in stray or unwanted animals from selling, giving or otherwise transferring a live animal for experimentation or testing.

**AB 2305/1453 by Assemblymember Richard Bloom re: Orcas. Support. Passed.** Prohibits captive breeding of orcas or their being held in captivity (after the death of those currently held in captivity), and prohibits the use of orcas for display, performance or entertainment purposes. This bill did not go through the conventional legislative process, and ended up being passed and approved by the Governor as a budget amendment.
